Executive summary

Assessment, verification & moderation policy

Appropriate and accessible assessment supports students' learning and encourages their ambition and achievement. The integrity and consistency of assessment processes and practices are essential in order that learners' qualifications are valued by the learners themselves, employers, other educational institutions, the public and other interested parties.

Awarding organisations require centres to ensure standardisation in assessment, verification and moderation procedures and practice. This policy statement lays down the practice at South Essex College in order to establish best practice in assessment and verification. It also lays down the standards of service required to meet the expectations of learners.

Assessment at South Essex College should at all times be informed by the fundamental principle that students should be assessed only when they have acquired the necessary skills, knowledge and understanding and are ready to achieve. All verification and moderation activity should be informed by this principle.

Adherence by staff to this procedure will ensure that we word towards the College Groups strategic aim 1 (Provide teaching and learning that expands learners' horizons and enables them to achieve the qualifications they need to give them life-time choices). This will ensure that stringent standards are set and maintained for the submission and marking of assessed work.

Policy Statement

Assessment, verification and moderation

- 1. Assessment will meet the needs of the individual learner in line with the Teaching and Learning Strategy.
 - 1.1 Initial assessment will form an accurate basis for identifying the appropriate study programme which will meet the ambition and aspirations of each individual learner.
- 2. Assessment and internal standards verification/moderation will exemplify best practice and will meet the requirements of awarding organisations and National Occupational Standards where relevant.
 - 2.1 Assessors and Internal Verifiers/moderators must be aware of the requirements of awarding organisations and National Occupational Standards where relevant.
 - 2.2 Staff development will be provided to ensure staff are trained and updated on awarding organisation requirements and procedures.
 - 2.3 Awarding organisations will be made aware of any changes to Lead Verifiers/Quality Co- ordinators by the Quality and Compliance team in line with the specific awarding organisations own rules and regulations.
 - 2.4 Curriculum Leaders to ensure the Quality and Compliance team are made aware of any centre updates including staff details and will inform awarding organisations.
- 3. Staff who carry out assessment and internal verification of qualifications must meet or be working towards the requirements set by the awarding organisations.
 - 3.1 Staff will be provided with the necessary development for them to achieve assessor and verifier awards where appropriate and subject to Staff Development approval.
 - 3.2 Staff will be assisted by the College Group to gain the awards and to be kept updated with any changes or amendments from the Awarding organisations. This will include any Continuing Professional Development (CPD) which maybe an awarding organisation requirement.
 - 3.3 Staff will be required to provide evidence of any qualifications obtained appropriate to the role. Awarding organisations may request to see copies of a staff members qualification certificates or a CV.
 - 3.4 Staff teaching on NVQs must be occupationally competent and hold the relevant assessor and verifier awards stipulated by the awarding organisation
- 3.5 All staff who are occupationally competent to assess are equally competent to

- 4. Each College and School will implement an assessment and verification process compliant with College policies and the requirements of awarding organisations, awarding organisations' guidance and National Occupational Standards.
- 4.1 Each course or programme of study will have an assessment plan, which is made known to learners and other relevant stakeholders at the start of the programme of study and which is logged on ProMonitor, Smart Assessor or equivalent.
- 4.2 The Curriculum Leader will be responsible for the implementation of the plan and ensuring assessments take place.
- 4.3 Each course or group of courses will have a named lead internal verifier/moderator and an appropriate number of internal verifiers/moderators.
- 4.4 Individual assessment briefs will be internally checked before being distributed to learners, where assessment is not prescribed by the awarding body. If any issues are identified by the Internal Verifier, they should be addressed by the Assessor prior to issue.
- 4.5 The Curriculum Leader will ensure that sampling plan is in place and that a representative sample (a minimum of 4 students unless stipulated by Awarding Organisation) of assessment decisions from all assessors is verified or moderated.
- 4.6 Where IV takes place in the workplace, any health and safety issues which are noted during the IV visit must be reported to the College health and safety representative to action as appropriate.
- 4.7 Assessments will be carried out to meet the requirements of awarding organisations and the National Occupational Standards and will follow the fundamental principle that learners will be assessed only when they are ready to achieve.
- 4.8 Assessment decisions will be made promptly, and written feedback given to students/candidates with 15 working days of assessment including internal verification unless stipulated differently by the awarding organisation.
- 4.9 The outcome of students' assessment decisions must be tracked within 5 working days of assessment marking. Teachers must ensure that assessment submissions have been uploaded onto ProMonitor (S has been placed onto ProMonitor), Smart Assessor or equivalent within 5 days of submission and assessment grade is uploaded onto Pro Monitor, Smart Assessor or equivalent within 15 working days of assessment date.
- 4.10 Feedback should (within awarding organisation requirements) comment on what has been done well and provide guidance on how work can be improved.
- 4.11 Feedback should include the correction of errors in spelling, punctuation and grammar.

- 4.12 The Curriculum Leader is responsible for ensuring that teachers are aware of where assessed student work (electronic and paper-based) will be stored. Electronic work must be stored in either the department's quality folder and clearly labelled by course, year and unit or in an approved portfolio system such as SMART assessor.
- 4.13 The Curriculum Leader must ensure there is a secure place to store paper-based student assessments within the department. Assessed work must be clearly marked by academic year, course and unit.
 - The Curriculum Leader must ensure a sign in/out process is in place for student paper-based portfolios which must be adhered to.
 - Tracking, Assessment feedback sheets and internal verification records must be stored securely and safely for three years and be made available for audit.

Student work is to be retained and made available to awarding organisations as per their stated requirements and for a minimum of 12 weeks after the completion of their programme.

- 4.14 The outcomes and any actions resulting from internal verification/moderation are to be followed up, acted upon, reported and signed off by Head of Schools and reported to the Quality Executive Board.
- 4.15 Appeals are to be documented and where appropriate, forwarded on to the external verifier/standards moderator, in line with the awarding body's requirements.
- 4.16 Standardisation/moderation should take place when a unit or assignment is delivered and assessed by more than one person, standardisation must be carried out before any formal assessment and internal verification have taken place. Standardisation is the process to discuss and mutually assess a sample of learner work to reach a consensus. This will be done with reference to the assessment criteria and assessment guidance provided in the gualification specification.
- 4.17 An audit of the internal verification and standardisation/moderation processes in each School will take place at least once each year with formal reports presented to the Quality Executive Board.
- 4.18 Students should not be provided with grades until internal verification of assessment decisions have been made. Students should be made aware that grades are subject to moderation from awarding organisations and can be altered as a result of this process.

5. The College Group appeals procedure will apply to assessment and internal moderation decisions

- 5.1 Students will be made aware of the College Academic appeals process (stage 1-3)
- 5.2 A student has the right to appeal to the awarding organisation once they have been through the College internal appeals process
- 5.3 Students will be made aware of the potential consequences of appealing to an awarding organisation.

6. The Assessment, verification and moderation policy will promote equality and diversity and be consistent with and complementary to all other College policies

6.1 Equality of access to fair and reliable assessment is guaranteed to all students and candidates.

- 6.2 Students who wish to have prior experience and /or learning accredited will be covered by the procedure for recognition of prior learning (RPL) exemptions/equivalency.
- 7. The operation of the assessment and internal verification/moderation procedures will be monitored through the Quality Calendar and by the Quality Executive Board.
 - 7.1 Compliance with assessment and internal verification/moderation procedures will be monitored through the quality calendar, team meetings, annual course reviews and the School reviews and will be reported to the Quality Executive Board by the Deputy College Principals.
 - 7.2 Feedback from students on the assessment process will be gathered through such mechanisms as student surveys, forums and meetings with course representatives and student focus groups.
 - 7.3 External verification/moderation reports will be sent to Heads of Schools and Curriculum Leaders for action. Head of Schools will provide updates on progress towards these actions to the Deputy College Principals.
 - 7.4 Reports will be produced to summarise the performance of each curriculum area and scrutinised by Quality Executive Board.
- 8. This applies to any programme or course which intends the delivery of learning through means of distance learning and/or assessment for the majority or all of the programme.
- 8.1 Any programme or course must ensure that they meet the awarding organisation minimum requirements to be able to use distance learning or distance assessment.
- 8.2 Online learning where a blended approach is used including a mix of face to face on campus assessment and via online platforms will adhere to the requirements set by the relevant awarding organisations which is separate from distance learning.
- 8.3 Tutors, assessors must understand, and follow, any qualification and unit-specific requirements for delivery or assessment that are set out in the qualification specification by the awarding organisation.
- 8.4 Distance learning and assessment may not be the right approach for some learners so it is important that Schools recruit with integrity. Distance learners will need to have the technical and communication skills to enable them to work independently and communicate effectivelyNo distance learning should be delivered without permission from the Executive Director of Quality, Teaching and Learning to ensure all awarding organisation requirements are met. Distance learning programmes will be approved by the Deputy Principal (Curriculum & Quality).
